### Terms and Conditions:

1. Any body that is an arbitration organisation or centre and any other body approved by the APRAG Committee ('Committee') may apply for membership.
2. A tertiary institution which demonstrates to the Committee's satisfaction its interest in arbitration may apply for associate membership. An associate member does not have the right to vote at APRAG meetings.
3. The Committee may in its absolute discretion decide whether to admit or not admit an applicant for membership or associate membership.
4. The Committee may in its discretion determine that fees shall be paid by members and associate members and, if so, in what amounts for each class of membership.
5. Members of APRAG shall at each general meeting elect a President and Vice-Presidents who shall compose the Committee and manage the affairs of APRAG.
6. Members may have the right to attend the general meetings of APRAG in person or through a proxy.
